The Pandemic continued to impact Division's activities. A new IPG grant for CSL outreach was submitted and received. The CANN subdivision received \$10,200 in donations in 2021which was a 29% decrease. Membership dues and allocations were increased by 50% due to the onetime ACS allocation. The Division's online workshops were not as successful as expected due to the tiredness of Zoom participation. The workshops for graduate students were very successful due to their low cost and the need to share safety expertise. Also, the Division received a non-meeting grant in the amount of \$5000.00 to support graduate student learning. Investment income did show a positive impact of 45% over budget.

Chair-Elect Report Spring 2022 National Meeting San Diego, CA

2022-02-23

Audit Committee report

On 2022-02-22, the Chair, the Immediate Past Chair, and I met with the Treasurer as the Audit Committee. Note that the meeting did not constitute a full audit in the regular accounting sense but was merely a review of the Division's financial position and current account statements. The review consisted of:

- The CHAS Balance Sheet and Profit and Lost Statement.
- The CANN Profit and Lost Statement for 2021 and since CANN became a subdivision.
- The 2021 ACS Divisional financial report as submitted;
- Three months of Division checking account statements (Bank of America);
- The 4Q2021 managed investment account statement (TIAA; listed as "Savings" on the Division's accounts);
- Discussion of the 2021 tax return and filing method;
- Future financial concerns.

The Division is currently carrying more than 2 years cash in the checking account, a very conservative reserve. This is partially because of the anticipated need to separate the finances of the CANN subdivision as they seek recognition as a full ACS Division; it was noted that this should take place at the end of a fiscal year to avoid potential for errors and extra expense to the Division.

We noted that the checking account was approaching the \$250,000 limit (per institution, per accountholder) for FDIC insurance coverage of the checking account, but it was decided that the limit would not be exceeded in the immediate future. We also noted that the checking account does not bear interest, and that perhaps moving some of the reserve into a safe cash-equivalent investment such as 2- or 5- year Treasury bonds might be appropriate. The Treasurer recommended that \$30,000 be moved to the managed investment account. The group approved the recommendation.

Tax filings for 2021

It is necessary for the Division to electronically file 2021 taxes because of new IRS requirements. There is no free software or web application to accomplish this, so it was decided to use Intuit, the maker of the QuickBooks software currently used for accounting, to file the taxes, for a reasonable fee.

Workshop financial models

The Audit Committee also informally discussed the harmonization of financial models for the various educational offerings of the Division. The sense of the committee was that there should be a consistent set of procedures. The Chair and the Chair-Elect will take the issue forward, consulting with the EC and relevant stakeholders; the issue will also become input for the strategic planning process.







Cannabis Chemist Certification

Senior Advisory Committee Chair Russ Phifer in conjunction with CANN EC members have developed the framework of a Cannabis Chemist Certification program to provide a professional certification resource for cannabis chemists.

Members of CANN's EC completed writing and reviewing the professional cannabis chemist exam which is now in the final suitability testing phase. CANN plans for its launch in May of 2022.

To oversee and continue the development of the cannabis chemistry certification, CANN Chair Julia Bramante and Chair-Elect Kyle Boyar have been appointed to the Board of the National Registry of Certified Chemists (NRCC).

Programming Committee Report Spring 2022 National Meeting San Diego, CA

For the time being and for the foreseeable future, National meetings will be hybrid – a mix of in-person and virtual attendance and presentations. This allows for increased attendance from international authors and attendees and flexibility as travel restrictions continue to evolve.

ITEM 1: Updates from F21

There were no new items presented at the F21 meeting and therefore no updates to report here.

ITEM 2: Update AI 108

Production of CAAG was moved to the duties of the Immediate Past Chair in 4/21 and therefore we should remove the following from AI 108.

The Programming Committee develops and publishes "CHAS At A Glance" pamphlet for each National meeting, describing the technical program schedule, social events, workshops, and symposia and events of interest to the Membership.

ITEM 3: Question on Nominations & Election Committee (AI 110)

According to our Bylaws, Standing Committees are supposed to have 2 members.

The composition of each Standing Committee shall be at least two Division members, one of whom shall be appointed as chair by the Chair of the Division as mentioned elsewhere in these bylaws.

Technically, I think that they all do (at least nominally) except Nominations and Elections. We might need to rethink that the Immediate Past Chair is the sole person who comes up with the election slate. Right now it just says that the IPC is the Chair of N&E.

Education Program Team Report Spring 2022 National Meeting San Diego, CA

The Education Program Team (EPT) is alive and active and promoting a variety of professional development opportunities for CHAS membership. There are a large number of volunteers interested in getting involved with the EPT - great! We are looking for new ideas for interesting programs and need help promoting those that are in the pipeline. I have proposed three "training tracks" for our efforts. These three "training tracks" could be managed under the EPT umbrella. Each is different enough in terms of logistics to separate out from a management perspective, but should be considered part of the overall program.

Full day chemical safety workshops by zoom or in person

Approximately 8 professional workshops about general lab safety and special hazards associated with laboratory operations. Audience is industry and academia. Costs generally about \$300, with presenters splitting net revenues with CHAS.

Specialty webinars, seminars, and workshops

Topics to include safety culture, safety information, and other general safety and safety management topics. May be funded by other ACS sources; revenue splits depending on arrangements with funding sources. Could include programs established through the ACS Safety Office.

Presentations for students, graduate & undergraduate

Topics specifically of interest to the academic community, including those interested in pursuing safety careers and in advancing safety programs at their institutions. Generally presented as webinars of 1-4 hours in length; revenue splits depending on arrangements with funding sources. Could include programs established through or sponsored with the ACS Safety Office. Could also include the ACS Safety Office online eLearning program for promotional purposes.

Regardless of this and any other proposals, the details of how to incorporate EPT into a seamless effort will be discussed as part of the upcoming Strategic Planning session, which should result in changes to the Administrative Manual to reflect both organizational management and any applicable financial procedures.

Development Committee Report Spring 2022 National Meeting San Diego, CA

The CHAS Development Committee was established to enhance opportunities for external funding and sponsorship to advance the mission of the division. It serves to support the mission of CHAS by holding responsibility for the solicitation of funding (primarily external to ACS and CHAS membership) for CHAS activities such as: National Award for Achievement in Chemical Safety, other awards under CHAS stewardship, grants and fellowships, CHAS-operated workshops, outreach events, etc.

Development opportunities in 2021 reflected the pandemic-driven challenges experienced in the previous. Although interest in sponsorship is increasing, measured by more frequent communication and soft commitments, it is the return to in-person events that is on the minds of previous, current, and potential donors. In its first full year of operation the Committee efforts have focused on developing workflows necessary for sponsor tracking, continued outreach to known and existing sponsors, establishing priority opportunities for the division, and surveying CHAS members for new opportunities.

New for 2022

Following the most recent call for volunteers I am very pleased to report that the Development Committee will double its membership! Kimi Brown has graciously volunteered to assist with this important committee and I am extremely excited to continue to work with her and I had in her previous role as Awards Chair.

Continued Best Practices:

Ideally the Development Committee will act upon requests made by CHAS stakeholders (e.g. officers and committee chairs) in support of current or new CHAS activities. Recognizing that alignment of goals will not always match the interest of sponsors the following workflow will help identify new sponsor leads:

New sponsorship leads

- 1. CHAS members forward contact information and any additional context of the potential sponsor to the Development Chair.
- 2. Development Chair contacts lead with copy to the CHAS member who generated the lead and/or relevant stakeholders. This initial contact includes a list of ongoing interests and needs of CHAS, or more specific opportunities depending on the context of contact.
- 3. Confirmed sponsorship will be copied to the Treasurer for invoicing.
- 4. Thank you notes should originate from CHAS Chair and/or originating stakeholder

Continued sponsorship leads

1. Development will provide regular updates to existing sponsors and encourage increased donations. (*This is dependent on cooperation from CHAS stakeholders)

- 2. Priority consideration and right of first refusal should be granted to existing sponsors, but funding levels should be adjusted to match actual cost increases
- 3. New Division priorities will be offered to continued sponsors "early access opportunity"

6-month Goals for Development Committee

- 1. Attract and confirm 5 new sponsors
- 2. Increase giving from current sponsors by 20%
- 3. Establish CHAS priorities for sponsorship
- 4. Establish more regular advertisement opportunities for sponsors

Longer term Goals for Development Committee

1. Fully fund the ACS National Award for Achievement in Chemical Safety

Regional Meetings Committee Report Spring 2022 National Meeting San Diego, CA

Committee Activity [2021-2022 – from Annual Report]

From - CHAS Regional Meetings - 2021 Annual Report

Due to the limitations for regional meetings this year, the participation in the award program for safety programming in regional meetings was below our typical funding of five programs, each with \$500. This year, we funded two groups with \$500 each. These were very strong programs and will serve as extremely valuable investments in the future of CHAS programming in regional meetings.

A strong component of providing funding for regional meetings has come from the partnership with Marta Gmurczyk's office, Senior Safety Programs Manager, in the ACS Scientific Advancement Division of the ACS. Marta is regularly providing coupled funding to regional meeting that receive our award and this is a very strong component to the ongoing growth of CHAS's future funding of safety programming in upcoming regional meetings.

Two regional meetings granting funding in 2021:

NRCC Liaison Report Spring 2022 National Meeting San Diego, CA

NRCC is now into our 55th year as a professional certification Board, and we continue to grow in scope and direction. As a CLIA approved Board for certification of Lab Directors of High Complexity Testing Laboratories, we have long had a focus in the clinical & toxicological fields. Maintaining that approval comes with a responsibility for rigorous standards and procedures that we work hard to uphold. Over the years we've added programs for environmental & industrial hygiene chemists & laboratory safety professionals, all programs designed to assure expertise in each field.

For 2022, the Board has authorized a new certification program for Cannabis Chemists (CANN-C). The program was largely developed by a group from the CANN subdivision of CHAS. The final education & experience requirements have been drafted, an exam prepared and vetted, and we expect a roll out of this program in time for the ACS Meeting in San Diego. The Board believes it is important, given the rapid expansion of the legal cannabis market, that laboratories doing analysis to assure safe products have highly qualified chemists working in and supervising those labs. Many cannabis chemists are also involved in extractions, and others in cannabinoid research, so the program is designed to show a well-rounded background and expertise in cannabis chemistry. The Board is hopeful that state departments of health will recognize credentialing for licensing of cannabis chemist is of great value to assure quality laboratory processes and procedures.

NRCC thanks our two representatives from ACS, Stefan Wawzyniecki (NRCC President for 2022) and Joe Pickel for the support of the organization.
